Warranty Purpose

Should a defect in material or workmanship occur during the specified manufacturer's warranty period, SeedMaster will assume specific repair responsibilities as listed in the Warranty Statement. This Warranty Statement is to be provided to the purchaser of each piece of new equipment with a SeedMaster serial number. Warranty begins on the date the product is delivered to the original retail purchaser of the product.

SeedMaster Manufacturing Responsibilities

SeedMaster Manufacturing's objective is to ensure that owners obtain maximum reliability and performance from all SeedMaster products. SeedMaster warrants its new products (when properly assembled, adjusted, maintained, and operated) to be free of defects in material and workmanship for the applicable warranty period to the original retail purchaser.

Warranty Summary

Subject to the specific warranties described below, SeedMaster will repair or replace, at SeedMaster's option, without charge for parts or labor to the **original retail purchaser**, any defective part of the equipment as follows:

Dealer Demo Units (equipment for dealer demonstration): **Twenty-four (24) months from the date of delivery to the original retail purchaser** unless otherwise stated within the Warranty Expectations. If not retailed within 12 months from the manufacturer's delivery to the dealer, the twenty-four (24) month retail purchaser warranty period will begin.

Owner Operator (equipment is used by owner only): **Twenty-four (24) months from the date of delivery to the original retail purchaser** unless otherwise stated within the Warranty Expectations.

Rental Equipment (equipment is rented by owner to third parties): **Twelve (12) months from the date of delivery to the original retail purchaser.**

Replacement Parts: SeedMaster will repair or replace, at SeedMaster's option, to the original retail purchaser, any defective part for Ninety (90) days from the date of delivery to the original retail purchaser, or the balance of the original warranty period, whichever is longer.

The parts warranty claim must be accompanied with proof of purchase from your SeedMaster Dealer. Warranty Credit will be issued upon receipt of defective part. All freight charges incurred to return defective parts to Dealer are the responsibility of the customer. Maintenance items such as chains, filters, hydraulic oil etc., are not covered.

Warranty Expectations

SeedMaster SMD Air Drill

Frame

SeedMaster's SMD Air Drill frames are warranted against defects in assembly, material, and workmanship for 60 months from the date of delivery to the original retail purchaser. Labor will be covered for a period of 24 months from the date of delivery to the original retail purchaser.

Openers

SeedMaster's SMD dual knife openers are warranted against assembly, material, and workmanship defects for the following periods:

1. Knives: 100% coverage on breakage for 12 months from the date of delivery to the original retail purchaser or 10,000 acres (whichever occurs first). This warranty does not cover wear or any aftermarket ground engaging tools.
2. Hydraulic Cylinders: 100% coverage on hydraulic defects such as internal or external leaks for 24 months from the date of delivery to the original retail purchaser.
3. Hardware: 100% coverage against assembly, material, and workmanship defects for 24 months from the date of delivery to the original retail purchaser.
4. Rubber Packer Wheels: 100% coverage against material defects for 12 months from the date of delivery to the original retail purchaser. Cuts, scrapes, or abrasions will not be warranted when used in excessively abrasive or rocky conditions.

SeedMaster UltraPro II Tank

Metering

SeedMaster's metering is warranted against defects in assembly, material, and workmanship for a period of 24 months from the date of delivery to the original retail purchaser.

Tarps

SeedMaster's tarps are warranted against defects in assembly, material, and workmanship for a period of 24 months from the date of delivery to the original retail purchaser.

Frame and Structure

SeedMaster's tank frame and structure is warranted against defects in assembly, material, and workmanship for a period of 60 months from the date of delivery to the original retail purchaser. Labor will be covered for a period of 24 months from the date of delivery to the original retail purchaser.

Paint

SeedMaster's paint is warranted against defects in assembly, material, and workmanship for a period of 24 months from the date of delivery to the original retail purchaser. Tank paint warranty is void if damage has been caused by chemical additive used on product being applied.

Warranty Expectations

SeedMaster Nova Series II Air Carts

Metering

SeedMaster's metering is warranted against defects in assembly, material, and workmanship for a period of 24 months from the date of delivery to the original retail purchaser.

Poly Tanks

SeedMaster's poly tanks are warranted against defects in assembly, material, and workmanship for a period of 24 months from the date of delivery to the original retail purchaser.

Frame and Structure

SeedMaster's tank frame and structure is warranted against defects in assembly, material, and workmanship for a period of 60 months from the date of delivery to the original retail purchaser. Labor will be covered for a period of 24 months from the date of delivery to the original retail purchaser.

Paint

SeedMaster's paint is warranted against defects in assembly, material, and workmanship for a period of 24 months from the date of delivery to the original retail purchaser. Frame and tank paint warranty is void if damage has been caused by chemical additive used on product being applied.

SeedMaster Ultra SR

Frame

SeedMaster's Ultra SR frames are warranted against defects in assembly, material, and workmanship for 24 months from the date of delivery to the original retail purchaser. Labor will be covered for a period of 24 months from the date of delivery to the original retail purchaser.

Openers

SeedMaster's Ultra SR openers are warranted against assembly, material, and workmanship defects for the following periods:

1. Knives: 100% coverage on breakage for 12 months from the date of delivery to the original retail purchaser or 10,000 acres (whichever occurs first). This warranty does not cover wear or any aftermarket ground engaging tools.
2. Hydraulic Cylinders: 100% coverage on hydraulic defects such as internal or external leaks for 24 months from the date of delivery to the original retail purchaser.
3. Hardware: 100% coverage against assembly, material, and workmanship defects for 24 months from the date of delivery to the original retail purchaser.
4. Rubber Packer Wheels: 100% coverage against material defects for 12 months from the date of delivery to the original retail purchaser. Cuts, scrapes, or abrasions will not be warranted when used in excessively abrasive or rocky conditions.

Warranty Expectations

Residue Management System

SeedMaster's Residue Management System is warranted against assembly, material, and workmanship defects for the following periods:

1. Tines: 100% coverage on breakage for 12 months from the date of delivery to the original retail purchaser or 10,000 acres (whichever occurs first).
2. Bushings: 100% coverage on failure or premature wear for 12 months from the date of delivery to the original retail purchaser or 10,000 acres (whichever occurs first).
3. RPM System: 100% coverage on failure or damage due to wear for 12 months from the date of delivery to the original retail purchaser.
4. Flex Coupling and Connector Links: 100% coverage on failure or premature wear for 12 months from the date of delivery to the original retail purchaser or 10,000 acres (whichever occurs first).
5. Scraper: 100% coverage on failure or premature wear for 12 months from the date of delivery to the original retail purchaser or 10,000 acres (whichever occurs first).
6. Hardware: 100% coverage against assembly, material, and workmanship defects for 24 months from the date of delivery to the original retail purchaser.

SMS Single Knife Tool Bar

Frame

SMS Single Knife tool bar frames are warranted against defects in assembly, material, and workmanship for 24 months from the date of delivery to the original retail purchaser. Labor will be covered for a period of 24 months from the date of delivery to the original retail purchaser.

Openers

SeedMaster's Single Knife air drill openers are warranted against assembly, material, and workmanship defects for the following periods:

1. Knives: SeedMaster branded knives are 100% coverage on breakage for 12 months from the date of delivery to the original retail purchaser or 10,000 acres (whichever occurs first). This warranty does not cover wear or any aftermarket knife providers.
2. Hydraulic Cylinders: 100% coverage on hydraulic defects such as internal or external leaks for 24 months from the date of delivery to the original retail purchaser.
3. Hardware: 100% coverage against assembly, material, and workmanship defects for 24 months from the date of delivery to the original retail purchaser.
4. Rubber Packer Wheels: 100% coverage against material defects for 12 months from the date of delivery to the original retail purchaser. Cuts, scrapes, or abrasions will not be warranted when used in excessively abrasive or rocky conditions.

Warranty Expectations

SeedMaster E-Series Air Cart

Metering

SeedMaster's metering is warranted against defects in assembly, material, and workmanship for a period of 24 months from the date of delivery to the original retail purchaser.

Poly Tanks

SeedMaster's poly tanks are warranted against defects in assembly, material, and workmanship for a period of 24 months from the date of delivery to the original retail purchaser.

Frame and Structure

SeedMaster's tank frame and structure is warranted against defects in assembly, material, and workmanship for a period of 24 months from the date of delivery to the original retail purchaser. Labor will be covered for a period of 24 months from the date of delivery to the original retail purchaser.

Paint

SeedMaster's paint is warranted against defects in assembly, material, and workmanship for a period of 24 months from the date of delivery to the original retail purchaser. Frame and tank paint warranty is void if damage has been caused by chemical additives used on product being applied.

Air Seeder Distribution Hoses

Hoses are warranted 100% for the first year and 50% for the second year against wearing completely through from the inside out. The distribution hoses are not warranted against breaking, kinking, pinching, being rubbed through from the outside, or deterioration due to environmental factors. Hose breakage at temperatures below minus ten (10) degrees Celsius will not be covered.

Batteries, Electrical Components, Engines, Hydraulic Components, Tires, etc.

These items are warranted directly by the respective manufacturers and are not covered by SeedMaster Manufacturing Warranty.

Warranty Limitations

Improper Use, Care or Repairs

Each piece of equipment from SeedMaster has an intended use, which is described in the operator's manual and our brochures. A failure occurring due to an unusual condition or operation not specifically intended by SeedMaster will not be warranted.

The operator's manual supplied with each piece of equipment gives instructions on safe, optimal, and productive operation of the equipment. Shortcuts in operation or disregard for these instructions may cause damage to the unit which will not be warranted.

This warranty is void on any unit that has been tampered with or that has been subject to negligent use, misuse, neglect, improper maintenance, accident, or which has had the serial number tampered with or removed.

SeedMaster Manufacturing Warranty is void if failure or damage is caused by improper equipment hook up, including but not limited to electrical and hydraulic connections.

SeedMaster Manufacturing Warranty is void if any unauthorized additions or modifications are made.

Repairs shall be made by SeedMaster authorized dealers only. The warranty does not cover, and SeedMaster shall not be responsible for costs incurred in connection with repairs made by unauthorized persons.

Loss or Damage During Shipment

The expressed warranty does not cover loss or damage during shipment, which is the responsibility of the carrier.

Limited Warranty

The owner's sole and exclusive remedy with respect to the quality, performance, or fitness of the equipment shall be as provided in the express warranties described above. SeedMaster shall have no liability with respect to any non-conformance of or defect whatsoever in the equipment (including any liability for direct, indirect, special, incidental or consequential damages) whether in warranty, contract, tort, negligence, strict liability or otherwise, including but not limited to loss of crops, loss of profits, delay in seeding or harvesting, costs incurred on account of rental or substitute equipment, or any other economic loss.

The warranty provided herein is in no manner a guarantee against the occurrence of any defect in material or workmanship, but only provides for the repair and replacement of defective items.

THE EXPRESS WARRANTIES OUTLINED ABOVE ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, CONDITIONS AND TERMS AS TO QUALITY, FITNESS OR PERFORMANCE OF THE EQUIPMENT, WRITTEN, ORAL, OR IMPLIED, STATUTORY OR OTHERWISE, INCLUDING, WITHOUT LIMITATION, ANY WARRANTIES OR CONDITIONS OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND ALL SUCH OTHER WARRANTIES, CONDITIONS AND TERMS ARE HEREBY DISCLAIMED AND EXCLUDED.

Dealer Responsibilities

The following responsibilities are to be performed when the dealer delivers a product to the purchaser or otherwise places it into warranty service:

1. Review and complete Pre-Delivery Inspection (PDI Form) with purchaser to ensure understanding of purchaser's responsibilities as related to maintenance, and the proper and safe operation of the product. Purchasers should be advised to have failed parts repaired or replaced immediately upon failure and that continued use **will** result in additional damage and excessive wear and could void the equipment warranty. **Note: Pre-Delivery Inspection (PDI Form) must be signed by purchaser prior to use.**
2. Complete the Pre-Delivery Inspection Form and forward to SeedMaster Manufacturing within 30 days of the delivery of the product. **Warranty registration is contingent upon product and retail purchaser registration.**
3. Review the SeedMaster Manufacturing Warranty Statement with the purchaser to ensure his/her understanding of SeedMaster Manufacturing's responsibilities, the Dealer's responsibilities, and the owner's responsibilities regarding warranty.
4. Provide warranty and service repairs as directed in SeedMaster Manufacturing's Warranty Policy and Technical Support Bulletins.
5. Provide Demo Unit warranty and service repairs during the demonstration period (one season), and for a period of no longer than 12 months after manufacturer's delivery.
6. Must complete Technical Support Training/Modules on a yearly basis to maintain Dealership Warranty Certification.

Owner Responsibilities

1. Review and complete the Pre-Delivery Inspection Form with your SeedMaster Manufacturing Dealer to ensure understanding of your responsibilities as related to maintenance, and the proper and safe operation of the product. Retain your signed copy of the Pre-Delivery Inspection to verify delivery of your new SeedMaster Manufacturing equipment and warranty registration of your product serial number.
2. Review the SeedMaster Manufacturing Warranty Statement with your Dealer to ensure your understanding of SeedMaster Manufacturing's responsibilities, your SeedMaster Manufacturing Dealer's responsibilities, and the owner's responsibilities regarding warranty.
3. It is the responsibility of the owner, at the owner's expense, to transport the equipment to the service shop of an authorized SeedMaster Manufacturing Dealer, or alternately, to reimburse the dealer for any travel or transportation expense involved in fulfilling this warranty.
4. The operator's manual supplied to you with your new SeedMaster Manufacturing equipment at the time of delivery contains important maintenance and service information. You should read the manual carefully and follow all maintenance and service recommendations. Doing so will result in greater satisfaction with your equipment and help to avoid service or warranty problems. Please remember that failures due to improper maintenance, adjustment, or operation of your equipment are **not covered by warranty.**
